Comments from 2023 Vestry Candidates

Submitted by Margaret Odell, Senior Warden

The candidates for Vestry in 2023 are Kay Dreamtrader, Mary Ogle, and Isabella Stephens. In lieu of a formal Nominating Committee, the Senior Warden asked each of the candidates to respond to the following 4 questions:

- 1. Why are you interested in serving on the TOTH Vestry at this time, and have you ever served on any Vestry in the past, either at TOTH or elsewhere?
- 2. What talents/gifts do you feel you have to offer to our parish?
- 3. How long have you been an Episcopalian and how many years have you been a member at TOTH?
- 4. What do you think is the most pressing problem facing TOTH in 2023?

Kay Dreamtrader

- 1. I have never served as a Vestry member. But I did serve as Vestry Clerk for TOTH from 2015 thru 2021. I have observed how the Vestry functions, how decisions are made, served through the last Rector transition, and seen how members transition on and off the Vestry. I believe that I can contribute valuable input to this Vestry if I am elected to this office.
- 2. Besides varied life experiences, I would bring excellent communication skills, insights into the psychology of group dynamics and a strong belief that God must be part of all decisions of the Church.
- 3. I have been an Episcopalian for as long as I have been a member of TOTH. I started attending services here in 2011. I had several meetings with Father Kelly and sought spiritual counseling with Mother Alicia for quite a long time. I was raised in the Wisconsin Lutheran Synod, but stepped away from that church in high school. For many decades after, I made a study of comparative religion. I recommitted to the Church in my 50th year.
- 4. The most pressing problem for TOTH in 2023 is obviously the selection and calling of a new Rector. But another important action will be the reorganization of ministries here at TOTH. The last few years have seen us go through many adjustments and transitions. We are now at a point where it is time to settle back into a sense of normalcy. Our parishioners have so many gifts to share with each other!

Mary Ogle

1. I've never served on a Vestry, but now I feel called to offer myself in service. I was inspired by the Anti-racism Zoom meetings. I am comforted that many of our local and Episcopalians respect diversity. I believe that God our Father values and loves everyone

on our planet equally regardless of skin color, sexual orientation, gender identity, and religious beliefs and practices. I also believe that we must live up to our God's expectations to have love, respect, understanding, patience, sharing, and gratitude. I strive every day for growth into these expectations: I pray for strength, generosity, intelligence, compassion, and mostly for humility.

Joined Los Alamos Episcopal mission in 1949 1950, before the TOTH church was built. At that time the church used shared space in one of the large wooden "Sundts" along Trinity Drive. Confirmed at TOTH. When I was in Scandinavia, I attended the Anglican Church and was a choir member.
- 4. Paying the mortgage on Kelly Hall, although our Rector search, maintaining our buildings and grounds, and increasing our diminished membership are also urgent.

Isabella Stephens

- 1. I hadn't really thought about being on the Vestry but, when I was approached about it, I spent some time praying and deliberating my answer, and I felt that I was being called to serve the parish in this way. I am also very curious and excited about this opportunity to learn more about the behind-the-scenes workings of the church. I was chosen to be a student member of the TOTH Vestry when I was 14 or 15, but due to school and a crazy home life at the time, I was only able to attend a couple of meetings.
- 2. For most of my time at Trinity on the Hill, I have primarily served through the choirs, especially the Youth Choir, and by being an acolyte. I believe I would bring a new perspective to the Vestry as a young adult with a different view of the world and the church.
- 3. I have been an Episcopalian since I was about four when my parents began to attend Trinity on the Hill, and I was confirmed in 2013 when I was 13.
- 4. I believe that the societal and internal influences pressuring political and secular changes and attitudes in and on our religious spaces are the biggest challenges facing TOTH in 2023.

Diocesan Convention Delegates

(2 candidates for a 2-year term, 1 alternate)

Joan Marks Moore

Why do I seek reelection (as a Deanery Delegate)? I have attended almost every Diocesan Convention since 1970 but had to sit in the back with the Clergy Wives. Since the death of my husband, an Episcopal priest, I sought the opportunity to attend as a voting Delegate and TOTH graciously gave me that opportunity. It has been a great joy to serve and renew old acquaintances in the Diocese for the past three years and I would very much like to continue that association.

How long have you been a member at TOTH? We came to Trinity on the Hill in 1968 and transferred our membership from St. John's in Idaho Falls. We remained active members until Mike was ordained in 1976, after which we attended the many New Mexico churches he served. However, we continued our membership at TOTH and our children also remained members until their lives led them elsewhere in the US. However, all have remained active Episcopalian. We did have a 9-year period after Mike became ill where we resided in Florida but he remained canonically a member of the DRG and continued to attend conventions until his death. I returned to Los Alamos in 2016 and once more became an active member.

Previous activities at TOTH: I have served as a Sunday School teacher, Tuesday Group, member of the TOTH Folk Mass musicians, and many years on the Altar Guild. I currently am on the Altar Guild and am a member of Women Alive.

What do you do outside of TOTH? As to outside activities, I am currently hibernating because of COVID but am a Docent with the Pajarito Nature Center.

Judy Crocker

Why do I seek reelection (as a Deanery Delegate)? I grew up in a family where we were all active in clubs and activities and where churches were #1 on the list. I've always thought support within the parish, deanery, and diocese are always "interesting" and critical, too. I'm happy to be running for re-election as a TOTH representative to the Deanery.

How long have you been a member at TOTH? I was interviewing for a job in Los Alamos in July 1971 and active at TOTH by fall! I've been a member of Episcopal church parishes all over the US and Europe.

Previous activities at TOTH: Over the years, I've been active in choirs (adult and youth), the Vestry, Shop on the Corner, Altar Guild, the Library, funeral receptions, pledge support meetings with TOTH families, youth and VBS activities, Sunday counting, filling Kelly Hall kitchen shelves and drawers, painting the parish Priest-in-Charge's house, Elders Group, landscaping, coffee hour scheduling, and several ministries. Being active within a parish makes for getting to know all of our members and families and helping to keep a parish active and growing.

What do you do outside of TOTH? I was a school librarian in Los Alamos for 32 years in the best job in the world. I was the Library Team Leader within the district for several years, a club sponsor, and a part of the first contract negotiated in LA. I sang with our Los Alamos Choral Society and Coro de Camara for many years and briefly helped our United Way. I worked with the LA Historical Society Endowment committee and was treasurer of Friends of Los Alamos

County Libraries for several years. During James's youth, I was active with the AAUW Playschool resale, and skiing and hockey team activities. In a very moist year, I'm an extremely active gardener, and I've been active with the Santa Fe or Albuquerque branches of the American Needlepoint Guild for 17 years and an independent member for 14 more years. For the last several months, I've been working with the Los Alamos AAUW branch, supporting the two Boulder County (CO) communities affected by a fire last year.

Blessing, Opening Prayer, Address to Annual Meeting

Father Raymond Raney opened the meeting at 12:05 pm with Drake's Prayer:

"Disturb us, Lord,
When we are too pleased with ourselves,
When our dreams have come true
Because we dreamed too little,
When we arrived safely
Because we sailed too close to the shore.

Disturb us, Lord,
When with the abundance of things we possess
We have lost our thirst
For the waters of life;
Having fallen in love with life,
We have ceased to dream of eternity
And in our efforts to build a new earth,
We have allowed our vision
Of the new Heaven to dim.

Disturb us, Lord,
To dare more boldly,
To venture on wilder seas
Where storms will show Your mastery;
Where losing sight of land,
We shall find the stars.

We ask you to push back
The horizons of our hopes;
And to push back the future
In strength, courage, hope, and love.

This we ask in the name of our Captain, Who is Jesus Christ."

Written aboard the Golden Hind, 1577, departing Portsmouth harbor.

Father Raymond then addressed the meeting, as follows:

"Since I was called Trinity on the Hill as Interim Priest in Charge, I've prayed Drake's Prayer for the Vestry as it opened each of its meetings. The prayer has been important as a challenge to how we think about a time of transition. Drake sailed on his quest to plunder Spanish ships and settlements for the gold that would fund the Defense of England. Elizabeth I has been Queen only for about 20 years. The Church of England was still in its infancy, and she was the subject of Papal proclamations calling for her assassination. Drake sailed against impossible odds, but succeeded. He wrote the prayer as he set sail.

Elizabeth I. 1558 – 1606

On September 26, 1580, English seaman, Francis Drake, returns to Plymouth, England, in the *Golden Hind*, becoming the first British navigator to sail the earth.

On December 13, 1577, Drake set out from England with five ships on a mission to raid Spanish holdings on the Pacific coast of the New World. After crossing the Atlantic, Drake abandoned two of his ships in South America and then sailed into the Straits of Magellan with the remaining three. A series of devastating storms besieged his expedition in the treacherous straits, wrecking one ship and forcing another to return to England. Only the *Golden Hind* reached the Pacific Ocean, but Drake continued undaunted up the western coast of South America, raiding Spanish settlements and capturing a rich Spanish treasure ship.

Drake then continued up the western coast of North America, searching for a possible northeast passage back to the Atlantic. Reaching as far north as present-day Washington before turning back, Drake paused near San Francisco Bay in June 1579 to repair his ship and prepare for a journey across the Pacific. Calling the land "Nova Albion," Drake claimed the territory for Queen Elizabeth I.

In July, the expedition set off across the Pacific, visiting several islands before rounding Africa's Cape of Good Hope and returning to the Atlantic Ocean. On September 26, 1580, the *Golden Hind* returned to Plymouth, England, bearing its rich captured treasure and valuable information about the world's great oceans. In 1581, Queen Elizabeth I knighted Drake during a visit to his ship. The most renowned of the Elizabethan seamen, he later played a crucial role in the defeat of the Spanish Armada. The explorer died in 1596 at the age of 56.

Just as Sir Francis Drake helped assure the future of the Church of England, so Trinity on the Hill will move forward in its search for a new rector, even in this time of Covid, until the right priest is called to help build the Kingdom of God in Los Alamos and Northern New Mexico. I'll close with another of Drake's prayers.

O Lord God, when Thou givest to Thy servants to endeavor any great matter, grant us also to know that it is not the beginning, but the continuing of the same unto the end, until it be thoroughly finished, which yieldeth the true glory; through Him who for the finishing of Thy work laid down His life, our Redeemer, Jesus Christ. Amen."

Call to Order

The meeting was called to order by Margaret Odell, Senior Warden, at 12:11 pm.

Housekeeping items

Claire Singleton was appointed Clerk of the meeting.

Approval of Minutes of the Annual Meeting February 7, 2021

Page 10 of the 2021 Minutes reads "Vestry Minutes 2020". Kay Dreamtrader clarified that it should read "Annual Meeting Minutes 2020." Judy Crocker put forward a motion to accept the amended minutes; Andy Light seconded. The motion carried.

Ben Schilling relayed a question from an on-line participant about where the Annual Report can be found on the web page. Another question was asked about how 2 people in the same household can vote separately. Nancy Coombs provided the answers to both questions.

Appointment of Readers

Judy Crocker and Marilyn Lisowski volunteered to be the Readers of these minutes.

Approval of Agenda

Andy Light proposed that the Agenda be accepted; Ellie Giovanielli seconded. The motion carried.

Explanation of Voting and Appointment of Tellers

Ballot papers were distributed and Margaret Odell explained how electronic voting would take place. Nancy Coombs was monitoring on-line votes and was appointed as Teller for those. Valarie Prestwood offered to help count the paper ballots.

Nominations and Elections

Margaret Odell read and explained the proposed change to the Bylaws:

Proposed Amendments:

"SECTION 1

(a) The Vestry shall consist of the Rector of the Parish, a Senior Warden, a Junior Warden and 10 seven (7) additional elected members. All members of the Vestry shall be qualified voters of the Parish."

.

(e) If there are insufficient adult nominations at the Annual Meeting election, the Vestry shall be allowed to operate at a reduced count of no fewer than 9 adult members. In such instances, nominations for any adult member position not filled at the Annual Meeting shall be voted at a special Parish Meeting."

Barbara Stoddard asked if the candidates for Vestry were present at the meeting. Three of the five candidates were present: Kay Dreamtrader, Linda Light, and Kelli Maginot. Of the Deanery and Diocesan Convention candidates, Judy Crocker was present; Jo Moore was participating online.

Review of 2021 Financials

Jeff Favorite's comments on the 2021 financials are in Treasurer's Report (attached to the Annual Report).

The second government PPP loan to TOTH amounted to \$34,500; the first PPP loan in 2020 was forgiven and this one is almost certain to be forgiven also. Without it, 2021 would have been devastating for TOTH and we would have had a \$20,000 deficit. Parishioners made up the difference and Jeff thanked them.

We still owe roughly \$475,000 on the Kelly Hall mortgage. We paid off approximately \$30,000 in 2021. We balanced the budget in 2021.

The Vestry presented the approved 2022 budget to the Annual Meeting, which is included in the Annual Report. The main feature to note is at bottom of page 49 of the Annual Report. We have a budgeted surplus of \$15, in other words we are proposing a balanced budget for 2022. Since we will not receive the \$34,500 PPP loan, how can we balance our budget? See the top of page 47, in the Revenue section. Pledges and contributions rose by approximately 23% compared to 2021, thus balancing the budget. Personnel expenses account for 54% of our budget. Mother Laurie does not take a salary.

George Marsden (watching online) asked if the LANS match will continue in 2022. The answer was that it ended before 2019; there has been no match since then. Employees can still donate through the major fundraising appeal at the Lab. There is no benefit to TOTH when employees make a matching donation through LANL. It would benefit TOTH more to have parishioners make monthly bank transfers.

George Marsden also asked why that budget line is still called "LANS match" The answer was that it should not be; the title of that line is incorrect.

Barbara Stoddard asked about the status of TOTH membership. Father Raymond's answer was as follows: Parishioner numbers in 2016: 239; 2017: 221; 2018: 239; 2019: 246; 2020: 232; 2021: 257. Nancy Coombs pointed out that the way we count viewers via Facebook live has changed compared to the way Father Chris counted online viewers.

Jeff Favorite noted that the budget is a spending plan that the meeting needs to approve. The Vestry has the option to change the budget in response to needs that may arise throughout the year. For example, we will not spend all the amount budgeted for Rector Support, i.e. \$20,000. That means that pledges only need to increase by 17% to balance the budget. Canon Lee Curtis (Canon to the Ordinary and Diocesan Transition Minister) advised the Vestry to maintain these budget lines for the new Rector.

Kandice Favorite asked why the budgeted Organist's salary is \$0. The answer is that the Organist and Choirmaster positions have been combined into one (held by Nelly Case) since Valerie Fassbender left.

Kelli Maginot asked how donations correlate with pledges. Father Raymond replied that, last year, donations were 20% above the amounts pledged. This is generally the case. Estimated giving for 2022 is up about 20%. Leni Moore responded (online) that pledges historically make up 50% of our actual giving.

Jeff Favorite thanked the parish for allowing him to serve as Treasurer and, before that, as Finance Committee Chair. He also thanked Leni Moore as incoming Treasurer. Mother Laurie thanked Jeff Favorite for his service as Treasurer.

Adoption of 2022 Budget

Richard Triplett proposed that the 2022 Budget be accepted; Judy Crocker seconded. The motion passed and the budget was duly adopted.

Filing of Wardens' and Ministry Reports

This year, the reports are not being presented in person but are in the Annual Report. Margaret Odell proposed that they be filed by acclamation; this was proposed by Karen Humphrey; seconded by Marilyn Lisowski.

Discussion: Father Raymond drew the meeting's attention to page 21, the Search Committee Report. He highlighted and explained the timeline of the search process. He will stay until the right candidate is found, the person whom God chooses.

Margaret Odell asked for prayers for the Search Committee as the next few months will be quite intense for them. She read aloud the names of the Search Committee members (listed on page 21 of the Annual Report). She offered thanks to Search Committee.

Margaret Odell then read the Prayer for Transition which we use at the regular Sunday services: "Almighty and everliving God, ruler of all things in heaven and earth, hear our prayers for this parish family. Strengthen the faithful, arouse the careless, and restore the penitent. Grant us all things necessary for our common life, and bring us all to be of one heart and mind within your holy Church. Look graciously on your Church of Trinity on the Hill, and so guide the minds of those who shall choose a rector for this parish, and the hearts of priests who may be called to this Parish, that we may receive a faithful pastor, who will care for your people and equip us for our ministries; through Jesus Christ our Lord. Amen."

Margaret Odell offered thanks to our Junior Wardens this past year. Having Co-Junior Wardens worked well but Paul Lisowski will be leaving Vestry after this meeting. She described how much help Mark Hartman gave to the Junior Wardens, despite his not being on the Vestry.

We hope to revive our Ministries in the coming year, with Vestry liaisons and reports back to Vestry.

The motion to accept the Wardens' and Ministry reports carried unanimously.

Recognition of Outgoing Vestry, Delegates, Treasurer, and Vestry Clerk

Margaret Odell presented Paul Lisowski with a framed plaque of Drake's Prayer. She also recognized Claudia Brookshire and Rebecca Sandoval, although they were not present. Jeff Favorite was presented with a name plate, mentioning his years of service as Treasurer. Kay Dreamtrader was presented with a similar name plate, showing her years of service as Vestry Clerk. Jo Moore is at the end of her term as Delegate to Diocesan Convention and Deanery meetings.

A brief recess was held before the results of the election could be announced, to allow for electronic votes to be cast.

Barbara Stoddard asked where Shop on the Corner fits into TOTH life. Its opening hours were explained, along with the fact that the Shop gave \$29,715 to charities in 2021. Karen Humphrey noted that the Shop is an Outreach ministry that includes workers from other faiths; she also

mentioned that the Shop appreciates the space that TOTH provides, along with Mark Hartman's help when needed. The Shop still tithes 10% back to TOTH. Online comments mentioned that the Shop on the Corner is an essential Outreach ministry.

Margaret Odell spoke about how much we would like to see things return to normal in the coming year.

Election Results

A total of 67 votes were cast. Mark Hartman, Rebecca Foley, and Kelli Maginot were elected to the Vestry for 3-year terms. Linda Light was elected for a 2-year term.

Jo Moore was elected as Diocesan Convention and Deanery Delegate. Judy Crocker will serve as the Alternate.

The change to the Bylaws concerning the Vestry was overwhelmingly approved.

Margaret thanked Claire Singleton and Nancy Coombs for preparing for the meeting and running the elections; she also thanked the Media Team for launching and maintaining our live-streaming operations, which may be here to stay.

Priest-in-Charge

The Year of Our Lord 2022

Trinity on the Hill's time of transition lengthened this past year after the Vestry and Search Committee decided not to call either of the two candidates who applied to be your next Rector. It's not easy being in transition. However, your Vestry renewed our agreement for me to continue as your Interim Priest in Charge until a permanent Rector is called. So, the Vestry and I continue to work to find ways of returning to "normal" even as COVID, the 'flu and other illnesses threaten our community.

Once I returned from vacation in September, the Vestry decided to make masks optional at the 10:30 Sunday service, and to continue requiring masks for the 8:00 am Sunday service and those services conducted in the Chapel. Shortly thereafter, we returned to offering the Common Cup at Sunday services, while still offering intinction by the priest at all services.

Our ministerial reach extends far beyond the doors of Trinity on the Hill, thanks to our Media Team members: Rick Rothrock, Bill Godwin, Richard Triplett, Robin Pekar, Michelangelo Lobato, Mark Staples, Rachel Greenwood and Nancy Coombs. Our services recorded 2,092 video views during 2022. Based on the formula we use in calculating viewers, each view potentially means 2.5 people are looking at the screen per view. That would mean we are reaching an estimated 5,230 persons during the year who are not in the nave with us on Sundays.

Additionally, to enliven the sharing of God's Holy Word, starting in Lent 2022 I arranged for the Venerable Patricia Soukup, Archdeacon of the Diocese, to preach one Sunday a month, and she will continue to grace TOTH with her presence in the months to come. Also, Susan Sprake and Samantha McRae volunteered to provide the Children's Sermon once a month, which helps spread the Sunday responsibilities in the absence of Mother Laurie Triplett

All our prayers continue for Mother Laurie. Her ministry has been curtailed since October because of illness. We pray for restoration of her health.

I must express my gratitude to Parish Administrator Nancy Coombs and Office Manager Claire Singleton, without whom we would not be able to manage the day-to-day operation of the office. My gratitude also extends to outgoing Senior Warden Margaret Odell and Co-Junior Wardens Lisa Rothrock and Mark Hartman. Their professionalism has been instrumental in keeping TOTH operational, as has the work of the entire Vestry.

I also am grateful to Vestry members Kelli Maginot and Maggie Moore for reinstituting the Children's Chapel on Sundays during the 10:30 service, and for organizing periodic gatherings for the young families in the Parish.

Also, Keith Stephens has been teaching youngsters for Sunday School between services, and I have led the Adult Forum in Sherrill Hall, beginning in December, in a seminar on the Mysticism Tradition of Christianity.

We also are blessed by the voices of Isabella Stephens and Andrea Schmidt as they lead the office of Compline on Sunday evenings.

With the urging of several of the men in the Parish, I facilitated the return of the Men's Study Group at 7:30 am Thursdays. Between eight and twelve men have participated in studying the lessons for the upcoming Sunday.

The Rev. Lynn Finnegan returned to Trinity on the Hill in July to preach and celebrate following her ordination to the Priesthood in June. She is serving as Assistant Rector at Church of the Holy Faith in Santa Fe.

In September TOTH celebrated the retirement of Organist/Choirmaster Nelly Case, who assumed the responsibilities as organist after Valerie Fassbender departed for seminary. Fortunately, we were able to call substitute musicians to provide musical leadership. Pianist Brian Huysman and Organist Margaret-Mary Sauppé have stepped in to share musical responsibilities, and the members of the Chancel Choir have proven the adage: those who sing, pray twice. The music at Trinity on the Hill blesses us all each week.

With the sage advice of your Vestry, we continue to work to restart the ministries that were idled by the pandemic, among them Outreach, Parish Life, Welcome, Worship, and Administration. Please consider what would interest you in the year ahead.

As the undulating waves of COVID infections ebb and flow, we all continue to move cautiously to prevent infections and keep one another safe in these trying times. So let us all continue to pray for our deliverance and for the transition into the future.

Almighty and everliving God, ruler of all things in heaven and earth, hear our prayers for this parish family. Strengthen the faithful, arouse the careless, and restore the penitent. Grant us all things necessary for our common life, and bring us all to be of one heart and mind within your holy Church. Look graciously on your Church of Trinity on the Hill, and so guide the minds of those who shall choose a rector for this parish, and the hearts of priests who may be called to this parish, that we may receive a faithful pastor, who will care for your people and equip us for our ministries; through Jesus Christ our Lord. Amen.

Worship Statistics 2022: narrative and totals grid below

In 2022, our worship services opened up entirely to live services on Sunday, and live in the Chapel on Wednesdays at 7:30 am and 12:30 pm. The 10:30 Sunday service continues to stream live on Facebook as well; the 12:30 Wednesday Healing service is streamed through Zoom. Additionally, a Sunday evening sung Compline service was begun in October

Father Raymond resumed services at both Sombrillo Nursing and Rehabilitation facility and Aspen Ridge.

The TOTH livestreamed worship services on Facebook (www.facebook.com/TrinityOTH), allow for live participation, real-time comments from Facebook account holders, and viewing after the livestream as a recording on our Facebook page. The weekly bulletins, readings, prayer lists, and children's bulletins are posted on the TOTH webpage (https://latoth.org/digitalworship/) and can easily be accessed by remote participants. The worship numbers below combine the worshippers in the church with the number of households tuned in during the service times, which means our estimate is most likely low.

We began extracting the sermons from the livestreamed services and posting them on Facebook later in the week, mostly with captions for better clarity. In 2022, there were 2092 video views (from all videos on the Facebook page) lasting 30 seconds or longer. Based on the formula of 2.5 persons per view, that comes out to 5230 total viewers, for an average of 103 views a week (including recordings).

Senior Warden's Report

This year continued to be difficult for Trinity on the Hill as we emerged from the COVID pandemic and slowly returned to in-person worship, meetings, and other events. To accommodate as many parishioners as possible, the 2022 Annual Parish Meeting was held in the Sanctuary on Sunday, January 23, following the 10:30 service, with live streaming of the proceedings. (See details in separate report.)

At that meeting, voters elected four new Vestry members: Linda Light for 2 years to complete Chandra Marsden's term; and Kelli Maginot, Rebecca Foley, and Mark Hartman, for 3 years each. At a special Vestry meeting on January 25, Margaret Odell agreed to serve as Senior Warden for another year, and Lisa Rothrock and Mark Hartman agreed to be Co-Junior Wardens.

Several personnel changes happened in 2022:

- Angela Keiter was hired as our Bookkeeper in the Spring. She has been assisted all year by Beth Pattillo, who has provided institutional memory to help Angela with straightening out TOTH's books and accounting system.
- Our Music Director, Nelly Case, resigned at the end of the summer. A hiring committee, chaired by Vestry member Linda Light, interviewed and recommended the hiring of Margaret-Mary Sauppé and Bryan Huysman, who have shared the organist's duties for the fall. Margaret-Mary also worked with the choir, which returned to the 10:30 services in September. We hope to be able to hire Margaret-Mary as our full-time Music Director when she completes her doctoral degree in the spring of 2023.
- The Vestry and Search Committee interviewed two clergy candidates for the Rector's position, but did not find either to be a good match for TOTH, so the search continues. (See Search Committee Report).

The past year has seen a number of heating and plumbing problems at TOTH. The boiler that heats the main Sanctuary and Old Parish Hall had to be replaced in the spring and repairs have been needed to the heating in the Office Wing and Kelly Hall. Junior Warden Mark Hartman has overseen these repairs, but Brad Wright has been an invaluable asset on a day-to-day basis as crises have arisen. The parish owes Brad a huge "Thank You" for his excellent care of our physical plant. It is impossible to calculate the value of all his volunteer time!

Early in 2022, long-time renters, Dance Arts Los Alamos, moved out. After several months of negotiations with potential renters and the Trustees of Property for the Diocese, a new rental agreement with All Individuals First (AIF) was completed in December. AIF is a local not-for-profit organization that provides services to mentally and physically challenged adults in the Los Alamos community. AIF will be renting the Undercroft, while Shop on the Corner has moved to the Old Parish Hall.

In June of 2022, the Executive Committee met with a representative from Church Insurance to make sure all our insurance coverage was adequate and complete. That meeting took place as fire loomed in the Jemez. We determined our coverage was more than adequate to replace the church buildings and contents, should the fire come into town. We did realize, however, that we needed to perform a comprehensive inventory of the buildings and contents, including photographs/videos, and descriptions of the contents. The Vestry and several parishioners have pledged to complete this work by early in 2023. Shortly after that insurance checkup, the office staff boxed up important parish records and financial documents and took them to Fr. Raney's house in Santa Fe for safe keeping until the fire danger was resolved.

Throughout 2022, Fr. Raney and the Vestry have kept an eye on the COVID levels in Los Alamos County. Since Easter, parishioners at all services in the main Sanctuary have had the option of sharing the Common Cup or receiving the wine and wafer by clergy intinction. Masks have become optional at the 10:30 services in the main Sanctuary and in most other locations within the church buildings. Masks are still required at the 8 am services in the Sanctuary and at all services in the Chapel. Community groups are once again using space at TOTH, and the congregation has had two potlucks. COVID and other diseases continue to be a concern but the church trusts that parishioners are maintaining their vaccination status and self-monitoring when they feel ill.

On December 11, TOTH welcomed Bishop Michael Hunn as he visited TOTH and confirmed Sam McRae and Valarie Prestwood. This visit coincided with our service of Advent Lessons and Carols, making it a glorious day to worship at TOTH!

I think you can see that this has been a busy year for TOTH and the Senior Warden. I will be concluding my term on the Vestry and my 2 years as Senior Warden, following the Annual Parish Meeting. It has been a privilege to serve as Senor Warden during this challenging time at TOTH. I pray that my service has helped ease the burdens of the Interim Rector and the Office Staff. I have certainly learned a great deal about what it takes to keep this church up and running. I will continue to be a member of this parish and pray for the Vestry and Fr. Raymond as they navigate 2023. I give thanks to the parishioners at Trinity on the Hill for allowing me to participate so fully over the past 3 years. God bless you all!

Search Committee

We began 2022 with a two-month posting of a call on The Episcopal News Service site, arranged and paid for by the diocese. This yielded us two candidates in early May, one of whom accepted a call to another parish before we even had time to interview him. And then we received another late submission, which restored us to two candidates. Both were interviewed on Zoom by the Search Committee, and then invited to visit for an on-site interview and private Eucharist with the Search Committee and the Vestry. Both were quite likeable personally, but it was the consensus of both the Search Committee and the Vestry that neither was a particularly good fit for TOTH.

Nevertheless, we learned a great deal from our interviews, which helped us to sharpen and refine our postings and our website information for prospective rectors. A fall posting on The Episcopal News Service that was to be arranged by the diocese fell through because of staffing and COVID problems at the diocesan offices, so we received no applications in the fall.

This experience prompted the Search Committee and the Vestry to undertake a more aggressive recruiting program on our own initiative and with our own funds. We have arranged to advertise not only in The Episcopal News Service, but in several other publications as well, and began our postings early in December, knowing that prospective candidates were probably consumed with the Christmas season right now, but in the hope that getting the word out early would encourage applications later.

Our search for a new rector has been affected by the same mass retirement of the Baby Boomer generation that is afflicting the business community. In the Episcopal Church in America clergy retirements annually are currently more than double new ordinations, a problem shared with many other denominations. In addition, inflation and high housing prices make it difficult for clergy to move, and our tight housing market here in Los Alamos is yet another factor. The Vestry has been working on means to address the housing problem, but there are no firm plans yet.

You in the congregation can help by letting family, friends and acquaintances across the country know that we are looking for a new rector, and by continuing to volunteer generously your time, talents, and treasure to the parish to keep it a vital and healthy faith community. We are convinced that, with God's grace, and with our dynamic church and appealing location, we will find the right person to shepherd us.

Buildings & Grounds

Co-Junior Wardens' Report

Greetings again from your co-Junior Wardens, Lisa Rothrock and Mark Hartman.

Yet another year has come and gone, and we have seen so many changes in Buildings and Grounds, as well as the Media Team. Below are some of our many accomplishments.

But before we get to those, we wish to send out an enormous THANK YOU to Brad Wright for all he has done to support the Junior Wardens this year in our time of need! His faithfulness, sage wisdom, willingness to babysit heating and plumbing systems, and attention to detail have been unsurpassed, and we are truly indebted to him.

The Media Team has grown to now comprise Rick Rothrock, Bill Godwin, Michelangelo Lobato, Nancy Coombs, Richard Triplett, Robin Pekar, Mark Staples, and Rachel Greenwood. These members are dedicated to and responsible for the excellent online streaming for all 10:30 Sunday and additional services. You can find our services streamed live or recorded at https://www.facebook.com/TrinityOTH/.

In February, we:

- Had the concrete outside the door to the Undercroft ground down so it would no longer cause further damage to the door;
- Worked with ABC Roofing to fix the roof to prevent further leaking in the men's restroom ceiling.

In March, we:

- Initiated the replacement of the furnaces for the sanctuary;
- Began looking for downstairs renters;
- Met with the original builders of Kelly Hall to determine the cause/remediation of the cracks in the walls and floors;
- Rerouted the wires from the sanctuary floor to the ceiling for safety; and
- Upgraded the choir mics.

In May, we:

• Completed the installation of replacement heating and cooling equipment for the sanctuary.

In June, we:

- Upgraded the wired internet cables in Kelly Hall for the Faith and Science Forum;
- Set up the media and sound system in Kelly Hall for the Faith and Science Forum;

• Continued work for our meeting with the original contractors for the Kelly Hall addition.

In August, we:

- Replaced zone valves for our office heating system;
- Received a quote for parking lot striping;
- (with the rest of the Vestry) diligently attempted to call EVERY SINGLE PARISHIONER in our records to check in, see how they were doing after COVID, ask if they wanted a clergy visit, and get overall feedback on the church.

In October, we:

- Wired up new thermostats for the office heating system;
- Began repair work on the Kelly Hall and Undercroft heating system;
- Opened an insurance claim with our church insurance to get an expert structural engineering opinion on the cracking problem in the Kelly Hall addition;
- Worked with the Scouts to have them remove their shed from our parking lot;
- Coordinated with numerous ministry groups to move Shop on the Corner into the Old Parish Hall:
- Were thrilled to have a beautiful garden and water redirection to the area outside the Undercroft, courtesy of Judy Crocker.

In November, we:

- Installed additional lighting in the courtyard and upper parking lot;
- Got the parking lots newly paint-striped;
- Assembled a volunteer snow shoveling crew and scheduled them through February (many, many thanks to Isabella Stephens, Kristina Brown, Michelangelo Lobato, Leni and Maggie Moore, and Thane Lawyer, and especially to Leni Moore for resurrecting our snow blowers!).

In December, we:

- Received the structural engineer's report, which said that the problems with the Kelly Hall
 addition were caused by poor soil compaction by the builder and are not covered under the
 insurance (they are not an act of nature). He also provided much guidance regarding
 minimizing further damage;
- Prepared the Undercroft area for our new renters, including new door hardware, plumbing for an additional sink, and other significant remodeling;
- Continued work on the Undercroft and Kelly Hall heating system (huge thanks to Brad Wright). It was poorly designed and implemented to begin with and has been failing to operate as it once had.

This past year has flown by way too fast, but we are blessed that so many in our congregation feel comfortable sharing concerns, questions, needs, or appreciation. All are, of course, always welcome. Beyond that, we ask your prayers for all Vestry members: those continuing, those incoming, and those outgoing. We are a strong, incredibly blessed church because of the efforts of all in this parish.

Parish Administrator

As Parish Administrator, my biggest challenge in 2022 was accounting. Before our former bookkeeper left at the end of January, she provided an overview of how to use the accounting system, ACS, to produce checks and enter income. Fortunately, Beth Pattillo volunteered to step in. She took over most of the bookkeeping and worked out what tasks I could do without too many errors. Then, last spring, the talented Angela Keiter joined us as bookkeeper. Under her guidance, we have begun updating our processes and now my accounting work is limited to entering contributions into Realm, our database, and transferring the results to ACS.

Prior to Angela, Father Raymond suggested I take accounting course to gain an understanding of how the books work. Last summer I took a semester course condensed into eight weeks through UNM-LA. It was completely book-based, with exercises and tests all done online, and no professor lectures. My not so young brain struggled to remember how to study, but it was also exhilarating to enter a new world. There may be another class in my future.

While Claire produces our tangible products, I manage the virtual products. The website colors change for seasons, the main pages get switched out and reworked. This year with the search committee, we added a Rector Search section, including an interactive submission.

Did you know you can watch and/or read the sermons on *latoth.org/sermons-2*? After selecting the sermon from the Facebook live stream, I use Adobe Premiere Pro to generate captions. Sometimes the captions need only a few corrections, sometimes they are amusingly incorrect

This past year the Vestry tasked me with reviewing room use agreements. Susan Sprake's advice was invaluable in the revisions.

Thank you also to Mary Ogle, who has been volunteering to do miscellaneous organizing tasks.

Throughout the year, I frequently assisted the Junior Wardens in gathering information or calling people. There was a lot of communication with the Boy Scouts as we came to a mutual decision that Trinity on the Hill was no longer the best place to meet and then getting their shed moved.

Rob Eaton put up drywall in the undercroft in preparation for the new tenant, but did not have the staff and time for finish work. With only one week before the holidays and tenants moving in, and no one available, I rolled up my sleeves and taped and plastered the seams and holes, and painted. I do have some experience, but I admit I was praying throughout the process for God to guide my hands.

I am blessed to have the opportunity to interact with so many kind and interesting people at TOTH. I truly enjoy all my work in the office. Thank you everyone!

Over the course of 2022, I settled into my position as Office Manager. It was my first full year in this role. Nancy and I have become used to our routine and find that we complement each other well. Job-sharing suits both of us.

My regular working hours are Tuesdays and Thursdays 1 pm to 5 pm; Wednesdays 9 am to 1 pm, and all day Friday. One of the positive aspects of job-sharing is that we can switch shifts if we need to or we can simply cover for each other if a switch is not possible. I am fortunate to have a long weekend every week!

Although many aspects of our job are shared, we each have our own strengths and weaknesses. Two of my responsibilities are producing the weekly bulletins and compiling and editing the monthly *Trinity Tidings*. On Fridays, I upload the 10:30 am bulletin, special prayer list, lessons, and children's bulletin to the web site, so that those watching at home can view them during the service. *Trinity Tidings* comprises articles that **you** (the TOTH congregation) submit to me. It is emailed as a pdf file to the parish when ready, made available in limited numbers at TOTH, and mailed to about a dozen parishioners who would otherwise not see it at all. I also edit and produce the Annual Report (this document) for the Annual Parish Meeting.

In addition to the above, my other tasks include: printing out and mailing the birthday and anniversary cards (with valuable assistance from Kay Dreamtrader); keeping an eye on the flower chart in the narthex (including sending out appeals for donations) and sending reminders to donors; preparing the monthly schedule of Lay Readers, Lay Eucharistic Ministers, Ushers, and the Media Team; sending weekly reminders to the scheduled volunteers (including Acolytes, who are scheduled by Susan Sprake, for which I'm very grateful); making and updating name tags (if you need one, just ask!); organizing staff birthday lunches – approximately every 2 months – and our recent Christmas lunch together; programming the electronic sign on the corner of Trinity and Diamond Drives; and emailing the Prayer Chain email list with requests and updates.

Following the resignation of Kay Dreamtrader as Vestry Clerk at the end of 2021, I was appointed Vestry Clerk at the Special Vestry Meeting held in January, 2022. Although I cannot be a Vestry member or vote at meetings because I'm employed by TOTH, attending Vestry meetings and being able to contribute verbally is always interesting and rewarding.

I think I finally got to grips with programming the electronic sign during 2022! The sign had been malfunctioning for several months (if not longer) due to the deterioration of its antennae, which are exposed to the elements year-round. These antennae provide communication between the computer in the office and the sign itself, or they are supposed to. Mark Hartman ordered and installed new antennae, for which I am very thankful. If there's a message you'd like to see on the sign, for example, an ad for your event or a special service at TOTH, please let me know.

The day-to-day running of the office is a shared task, involving welcoming visitors, answering phone queries, helping people make copies, sorting the mail, taking out recycling, keeping the printer operating correctly, etc.. I am blessed to have friendly and kind colleagues and especially a wonderful earthly boss.

Women Alive in Mind, Body & Spirit 2022

During 2022, Women Alive has been transitioning from meeting mostly on Zoom with a walk once a month to a more varied program. We still walk once a month, but we also meet at Church twice a month, with Zoom available for those who can't come in person. The other meetings in the month are Zoom only.

Here is the current schedule:

All meetings start at 7:30 AM

First Tuesday of the month: meet at a trail head and hike for half an hour followed by breakfast

at a restaurant.

Second and Fourth Tuesdays: meet in Sherrill Hall; one of our members provides breakfast as well

as a program or short devotion. Zoom is provided for those who

cannot be physically present.

Third and Fifth Tuesdays: meet on Zoom only with a program or devotion if someone has

volunteered, otherwise a more general discussion of topics

appropriate to the season.

Sometimes the devotion is very simple, for example, reading and discussion about a "Holy Person" from the book "A Great Cloud of Witnesses." At other times, attendees have provided longer programs, talking about a topic dear to their hearts. An example of this was a program on Sign Language. Our primary goal is to love, encourage and support one another in body, mind & spirit. We share what is on our hearts and minds in a place that is safe and confidential and end with special prayers.

Occasionally, one of our members invites the group to meet at her home for breakfast instead of in Sherrill Hall.

To be a member of Women Alive, it is not necessary to be a member of TOTH (or any church), nor is regular attendance a requirement. To join on Zoom, you do not even have to live in Los Alamos.

Meeting attendance averages 7 people, with some only attending when we walk and others only on Zoom. A total of 18 people came to Women Alive at least once in 2022.

Outreach Ministry

From Trinity on the Hill's Core Values:

"In our connection with the world, we reach out with God's love and message of hope, responding to the needs of others."

The Shop on the Corner is the backbone of our parish outreach endeavors. Please see separate report. Unfortunately the budget for Outreach for 2022 was a tiny 0.0012 per cent of the total budgeted expenses, and even that was not spent due to there being no Outreach Ministry chairperson. We have had several supplementary activities in which our parishioners have participated generously.

Our annual <u>Souper Bowl</u> offering was \$834, 100% of which was given to our local food pantry, LA Cares. In addition, every FIRST SUNDAY we celebrate FOOD SUNDAY with an offering of non-perishable foods, paper goods and hygiene articles. All these offerings are blessed by the congregation before turning them over to LA Cares.

Various donors from both the parish and the community stock the <u>Little Free Pantry</u> in the lower parking lot. Those in need are welcome to pick up whatever is on the shelves.

We were able to help out the Kairos Prison Ministry by donating <u>2023 calendars</u> this year, plus a few Bibles, greeting cards and note pads.

A few families brought in their <u>United Thank Offering</u> blue boxes for our ingathering on November 6. Others wrote checks for this effort to enable us to write a check for \$316, sent to the Diocese for TOTH's contribution to the Episcopal Church-wide project.

We participated in First United Methodist Church's annual Christmas <u>Adopt-A-Family</u> effort by adopting 9 families from the poverty-stricken community in Medanales, NM. Many thanks to Nancy Coombs for coordinating and to those who generously adopted families. Finally, we supported the Borderland Ministry's programs through the Shoebox Ministry.

Let us pray for God's guidance and for Him to provide leaders in the coming year as we attempt to serve Him and His people, perhaps by reviving the High School Friday Lunch, Vacation Bible School, Children's Christmas Bazaar, Mitten Tree, Epiphany offering for Hope Pregnancy Center, CROP Walk team, or whatever other ministries He is calling us to! Amen.

Office Manager

Stewardship Ministry

Due to the continuing disruption of the Covid pandemic, no official Stewardship Committee was formed, and no detailed Stewardship Campaign was conducted.

The Executive Committee of the Vestry (Fr. Raymond Raney, Interim Rector; Margaret Odell, Senior Warden; and Lisa Rothrock and Mark Hartman, Co-Junior Wardens) approved and implemented the distribution of Estimate of Giving cards, along with a letter from the TOTH Vestry. The Committee and Vestry deemed "Estimate of Giving" to be less threatening or uncomfortable than the term "Pledging."

As a result of this Stewardship message, 53 parishioners/parish families submitted Estimate of Giving cards, representing \$271,550 in planned donations to TOTH for 2022. The Finance Committee monitored actual giving and expenses throughout the year, with the assistance of Angela Keiter, TOTH Bookkeeper.

A similar Stewardship effort was carried out at the end of 2022. As of December 31, 2022, 43 Estimate of Giving cards had been returned, representing planned giving totaling \$259,210. Of these cards, 5 were submitted by folks who did not turn in cards for 2022. Of those parish families who responded last year, 15 have not turned in cards for 2023. If they were to give the same amounts they did last year, that could represent an additional \$61,230 towards the 2023 budget.

The Vestry continues to pray for the TOTH family to support our parish with their generous gifts of time, talents, and treasure!

Fortunately, Pianist Brian Huysman and Organist Margaret-Mary Sauppé have stepped in to share musical responsibilities, and the members of the Chancel Choir have proven the adage: those who sing, pray twice. The music at Trinity on the Hill blesses us all each week.

I have been grateful to the Venerable Patricia Soukup for guest preaching once a month since last Lent. I've also been aided by Susan Sprake and Samantha McRae who take on the children's sermon once a month.

Sunday mornings have been graced by Maggie Moore and Kelli Maginot as facilitators for the Children's Chapel following the Children's Sermon.

Since October Isabella Stephens and Andrea Schmidt have provided a sung service of Compline at 7 pm on Sunday evenings. During the week, we gather in the Chapel Wednesdays for a Rite I Eucharist at 7:30 am and for a Rite II Healing Service at 12:30 pm. Additionally, I am offering the

Financial Reports

Financial Audits for Parish

Due to the continuing disruption of the Covid pandemic, no official Stewardship Committee was formed, and no detailed Stewardship Campaign was conducted.

Treasurer's Report

The operating budget for 2022, accepted by the parish at the Annual Meeting in January 2022, was \$441,489. The budgeted operating revenues were set equal to the budget so as to present a balanced budget.

The final 2022 operating expenses were \$347,434, which was \$94,055 under budget. 75% of this savings was from lower costs for our Rector and Music Director. The final 2022 operating revenues were approximately \$367,279, which was \$74,210 under budget. We ended 2022 with a surplus of approximately \$19,845 due to lower actual expenses. The low actual expenses are not expected to continue into 2023 as we are actively recruiting a new Rector and a Music Director.

In 2022 we have been blessed with a new bookkeeper, Angela Keiter, who has made tremendous improvements to our finances. I would like to thank Angela for all she has done this year.

The internal financial audits are required by the Episcopal Church of the USA. The internal audit of the 2019 books was completed in 2021. The internal audit of the 2020 books has yet to be completed.

A budget of \$479,177 for 2023 is proposed in this report. This is \$37,688 more than the 2022 budget and \$111,898 more than the 2022 actual revenues. The Vestry has approved a 7.4% increase in Rector support and a 8.7% cost-of-living raise for most of the rest of the staff. The Vestry has also approved \$10,000 to cover costs associated with the search for a new Rector. Other increases in expenses come from an increased insurance cost and an expected increase in the cost of the mortgage due to increased interest rate expected this year.

On the revenue side, we once again adopted a balanced budget approach and are proposing revenue required to meet the expected expenses. Although this is a big increase from last year, we believe the parish will meet this financial need, as they have always done in the past.
